


# **Heavy-Duty Cast Aluminum Rear Differential Cover**

GM/Dodge 2500HD/3500HD trucks with 14 bolt 11.5" rear axle (will not fit trucks with coil springs)

## Installation Guide





#### **CONTENTS:**

- A (1) PPE Differential Cover
- **B** (1) Heavy-duty gasket
- **C** (1) One-inch Neodymium Magnet-Equipped Drain Plug (installed)
- **D** (1) 1/8" NPT plug (installed)
- E (14) M8 Flat Washers
- F (1) 3/8" Drain Plug (installed)
- **G** (1) 1/4" NPT plug (installed)
- **H** (14) M8-1.25 x 30mm Socket Head Cap Screws

#### ITEMS NEEDED:

8mm Allen Torque Wrench Recommended weight Gear Oil Oil Drain Pan Shop Towels Gloves Eye Protection



**Step 1:**Remove the brake line bracket and parking brake differential brackets.
Keep brackets for reinstallation in later steps.






**Step 2:** Remove the factory bolts and drain oil. Recycle oil.



**Step 3:** Remove stock cover.



### Step 4:

Trim (grind) down the parking differential bracket by removing a triangle parallel to the bolt hole. Cut the smaller grip completely off.

You may opt to round off the edge for a more finished look (as shown).





**Step 5:** Clean the mating surface.



**Step 6:** Align gasket to the PPE pan.






#### Step 7:

Reattach the brake line bracket and modified parking brake differential bracket in their original locations with new bolt hardware. Secure lines.

#### Step 8:

Mount cover and gasket to mating surface. Install bolts finger-tight to hold the cover in place and ensure the gasket is properly aligned. Tighten each of the bolts in a crossing pattern as shown below. Torque to 20-25 ft. lbs.



## Step 9:

Fill to sight-level with manufacturer-recommended gear oil.

Check for leaks.

Installation complete.
