




Heavy-Duty Cast Aluminum Front Differential Cover Dodge/Ram 2500 3500

Installation Guide





CONTENTS:


- A (1) PPE Front Differential Cover Dodge/Ram
- **B** (1) One-inch Neodymium Magnet-equipped Fill Plug (installed)
- **C** (1) 9/16" 18 #6 ORB Drain Plug (installed)
- **D** (14) M8 1.25 x 30 Socket Head Cap Screws

INSTALLATION:

- Step 1. Vehicle off, cool, and secure.
- Step 2. Place pan under differential to drain gear oil. Remove stock screws starting at the bottom. Pry off stock diff cover.

 Allow oil to drain completely. Recycle oil.
- Step 3. Wipe up remaining gear oil at the bottom of the housing.
- Step 4. Scrape the housing mating surface clean of old sealant.
- Step 5. Apply a continuous bead of RTV sealant into the PPE Diff Cover flange surface around flange holes. Leave no gaps.



- Step 7. Install remaining M8 screws
 (D). Tighten in crossing pattern
 as depicted. (Fig. 2) Torque to
 12-15 ft. lbs.
- Step 8. Tighten Drain Plug (C) snug.
- Step 9. Fill to manufacturer recommended level with manufacturer recommended gear oil. Tighten Fill Plug **(B)** 18-22 ft lbs.

Check for leaks.

This completes the installation.




