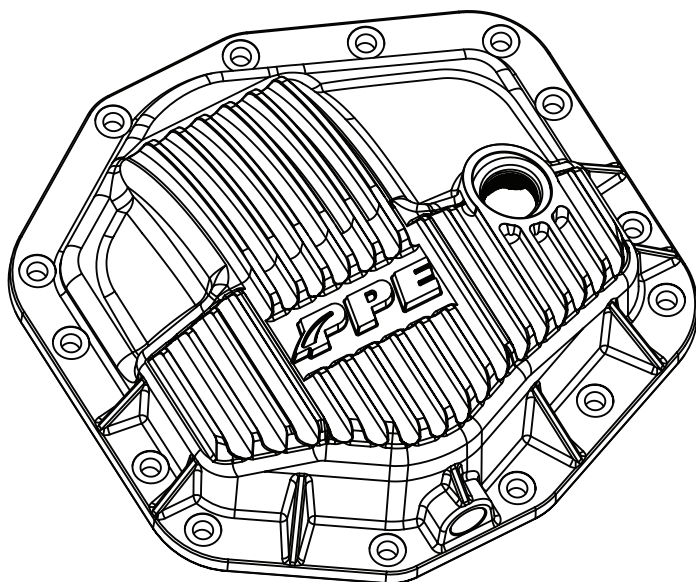

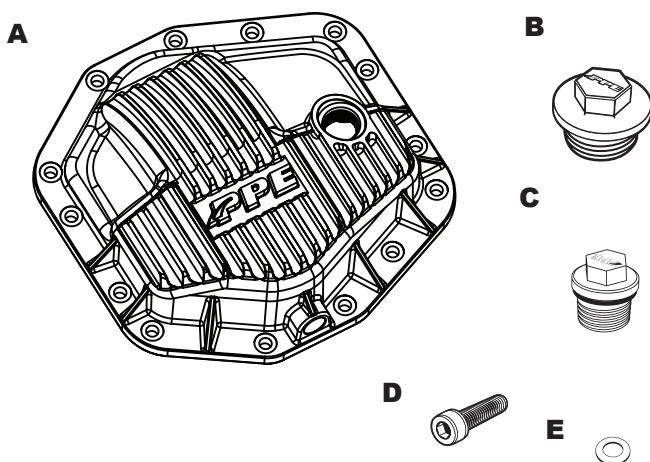

Disassembly:

1. Turn the vehicle off and allow time to cool down before installing.
2. The factory front differential doesn't have a drain plug so remove all factory differential cover bolts except for the topmost one. See FIG 1. Loosen the bolt but do not remove completely to help control the draining of the fluid. Slowly lift the cover slightly so draining can start.
3. When draining is complete, remove the last bolt, gasket and front differential cover.

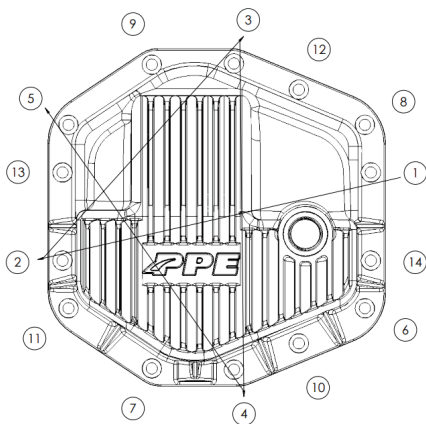
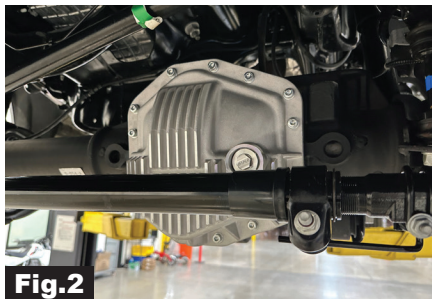

Installation:

4. *Install the PPE Front Differential Cover (A) and factory gasket with the M8 SHCS (D) and M8 Washers (E). See FIG. 2. Tighten in crossing pattern as depicted in Fig. 3. Torque bolts to 20-25 ft lbs. Check and tighten Drain Plug (C) to 15-19 ft lbs.*
5. *Fill to approximately 2.20 quarts. Tighten Fill Plug (B) to 18-22 ft lbs.*

Installation Complete.

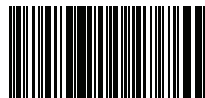
