



INSTALLATION


- Step 1. Vehicle off and secure. Engine Cool.
- Step 2. Remove stock cover bolts and nuts. Keep stock studs in place. Carefully drain fluid. Remove stock pan. Save and clean reusable gasket if there is one.

- Step 3. Thoroughly clean the housing mating surface of old sealant.
- Step 4. Apply a continuous bead of RTV sealant onto the PPE Cover flange and around flange holes. Leave no gaps.

(Fig. 1)

Step 5. Position Cover in place.
Do not smear RTV. Install
Screw (D) on each side of
the Cover to hold in place
(Fig. 2: Step 9, 10).
Finger tight for now.



Step 7. Install remaining screws.
Tighten in crossing pattern
as depicted in Fig.2.
Torque Screws 22-25 ft lbs
and replace factory nuts
back on studs
to 22-25 ft lbs

Tighten Drain plug 15-19 ft lbs

Step 9. Fill with manufacturer recommended differential oil.

Tighten fill plug 18-22 ft lbs

Check for leaks.

Step 10. Secure brake line clips to factory studs.

Installation Complete.
