


Heavy-Duty Cast Aluminum Transmission Pan

Installation Guide



CONTENTS:

- A** (1) *PPE Deep Transmission Pan*
- B** (1) *Removable, replacable filter 228058700 (installed)*
- C** (1) *One-inch Neodymium Magnet equipped Drain Plug (installed)*
- D** (1) *1/8" NPT plug (installed)*

INSTALLATION:

- Step 1. Vehicle off and secure. Engine cool.
- Step 2. Remove crossmember.
- Step 3. Loosen stock pan bolts allowing fluid to carefully drain over the flange edge. Recycle fluid.
- Step 4. Remove pan. Retain stock gasket and stock flange collars.
- Step 5. Thoroughly clean stock gasket, collars, and housing mating surface.
- Step 6. Tighten PPE Filter screws and NPT Plug if necessary **(B, D)**.
- Step 7. Install stock gasket on the PPE Transmission Pan flange. Install stock flange collars in the stock gasket.
- Step 8. Check for proper gasket alignment.
- Step 9. Install Pan to housing surface making sure the filter neck seats completely. Secure with two bolts through stock flange collars to hold Pan in place, finger tight for now.
- Step 10. Install remaining bolts.
- Step 11. Tighten in a crossing pattern as shown **(Fig. 1)**.
Final torque spec: 8-10 ft lbs.
- Step 12. Reinstall crossmember.
- Step 13. Add manufacturer-recommended fluid. Check for leaks.

Installation complete.





