


# Heavy-Duty Cast Aluminum Deep Engine Oil Pan

(114054000, 114054020)

Installation Guide



# **CONTENTS:**



- **A** (1) High-power Neodymium magnet equipped drain plug with copper washer (installed)
- **B** (1) 1/8-inch NPT plug (installed)
- C (23) M5 x 0.8 x 25mm socket head cap screws
- D (23) M5 flat washers
- E (1) Cast Aluminum Alloy Engine Oil Pan


## PREPARATION:

- Step 1. Vehicle off. Engine cool.
  Completely drain oil, overnight if possible.
  Recycle used oil.
- Step 2. Remove stock pan.
- Step 3. Thoroughly clean engine housing mating surface.

## **INSTALLATION:**

- Step 1. Apply a constant bead of engine-rated silicone sealant (RTV) into the machined channel of the flange, including around bolt holes.
- Step 2. Preassemble two of the kit's screws and washers (**C**, **D**). Position PPE Oil Pan in place by indexing the locating pins on the flange. Be careful to apply even pressure so silicone spreads uniformly. Install the two screw assemblies on opposing sides to secure in place, finger-tight for now. Install remaining assembled hardware (**C**, **D**) finger-tight for now.
- Step 3. Tighten in a crossing pattern as shown (FIG 1).
  Torque to 8-10 ft lbs.
- Step 4. Check and torque drain plug
  (A) to 15-19 ft lbs.
  Check and tighten 1/8" NPT
  plug (B).
- Step 5. Replace old oil filter if necessary.
- Step 6. Fill with manufacturerrecommended oil.
- Step 7. Start engine. Check fluid level. Check for leaks.

Installation complete.
