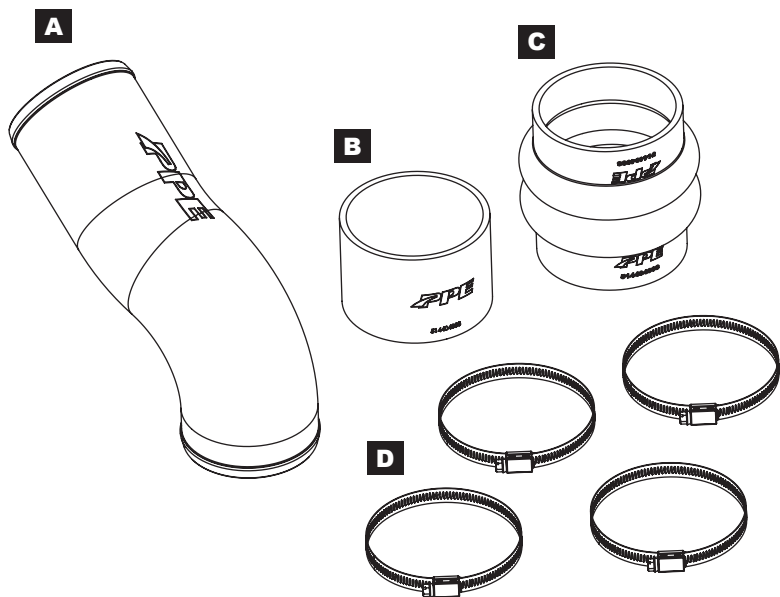

Installation Guide



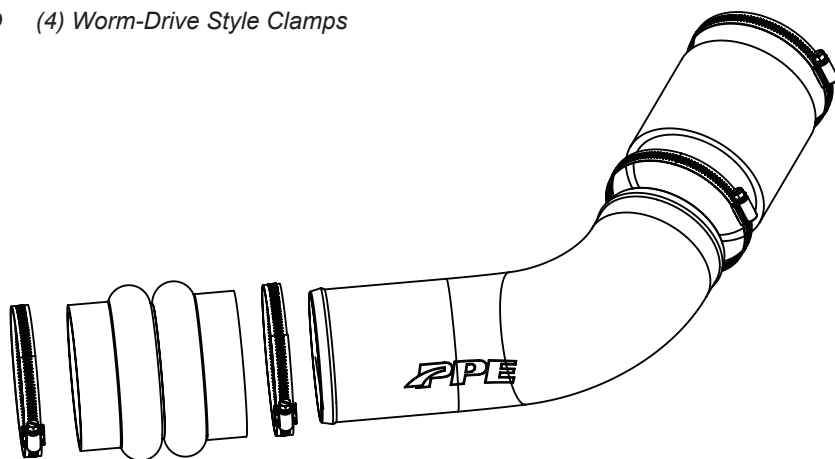
CONTENTS:

A (1) 304 Stainless Steel Intake Tube

B (1) 4-Inch Straight Coupler

C (1) Hump Coupler

D (4) Worm-Drive Style Clamps



INSTALLATION:

1. Park truck securely and turn engine off.
2. Loosen the two clamps on the stock rubber hose connecting the airbox and the air duct, then remove the rubber hose. **Fig.1**
3. Loosen the clamp over the turbo inlet, then pull out the rest of the air duct. **Fig.2**
4. Clean the PPE steel pipe and silicone couplers
5. Apply a thin layer of lubricant on the internal of both ends of the PPE silicone couplers
6. With clamp loosely attached, slide the humped coupler over the airbox outlet all the way in till it meets the stop. Tighten the airbox clamp down. **Fig.3**
7. Attach the straight coupler to the rear end of steel pipe, with clamps loosely attached.
8. Fit the front of the steel pipe into the humped coupler. Align then slide the straight coupler onto the turbo. **Fig.4**
9. Tighten the clamp over the turbo.
10. Adjust the steel pipe if necessary. Tighten down the last two clamps. **Fig.5**

Installation is now complete.
