INSTALLATION INSTRUCTIONS:

Step 1:

To gain access, the inner fender panel needs to be removed. A flat bladed screwdriver can be used to pry up the heads of the plastic fasteners.



Step 2:

With the inner fender out of the way, the lower driver side hose is accessible. A screwdriver is used to remove the clamps.



Step 3:

The stock hose may be hard to remove from the metal tubing. To ease removal, a 90-degree angled hook tool can be used to separate the hose from the metal tube.



Step 4:

Install the new PPE Performance Silicone Hose. Tighten the hose clamp to secure.



Step 5:

The cover is removed to gain access to the upper hose connection.



Step 6:

The upper connection is loosened and the hose clamp removed.



Step 7:

A long extension makes it easier to get to the lower clamp. That clamp is loosened.



Step 8:

Use a small 90-degree angled metal hook tool to separate the pieces. Remove the upper hose.



Step 9:

Before installing the new PPE silicone hose, make sure that the clamps are on and facing in a direction to make them easily accessible to tighten.



Step 10:

Remove the passenger side inner fender well. The lower passenger side hose clamps are then loosened.



Step 11:

Remove the stock hose.



Step 12:

With the clamps on loosely and oriented correctly, the lower hose is then installed.



Step 13:

Tighten clamps to secure.



Step 14:

The inner fender wells are reinstalled and the push fasteners are reinstalled.



Step 15:

Install and tighten second upper hose.
