

# To help depict the installation process we are showing the steps on an engine that has been removed from the truck.

## STEP 1

Disconnect stock down pipe from exhaust pipe.

Remove three (3) sensors from stock down pipe.



# STEP 2 Unbolt and remove the heat shroud from the stock down pipe.





**STEP 3**Remove mounting brackets from stock down pipe.



STEP 4
Unbolt and remove
V-Band clamp from
the stock down pipe.





**STEP 5**Remove stock down pipe.



STEP 6
Reuse V-Band
Clamp to install top
of Down Pipe.





**STEP 7**Reinstall three (3) sensors.



STEP 8
Reuse the V-Band
Clamp to connect
exhaust pipe to the
bottom of the new
PPE Down Pipe.





### STEP 9

Apply Executive Order decal on the engine shield for reference by a smog technician.
