






CONTENTS:

- A. (1) 4" Inlet Pipe
- B. (1) 4" Optional Straight Extension Pipe
- C. (1) 4" Angled Pipe
- D. (1) 4" Over-Axle Pipe
- **E.** (1) 4" 90 Deg Pipe
- F. (1) 5" Exhaust Tip
- G. (5) 4" Exhaust Kit Clamps
- H. (1) 3" Exhaust Kit Clamp

Note: Installation requires cutting OE Exhaust

Performance Exhaust System



DISASSEMBLY:

- Step 1. Turn the vehicle off and allow time to cool down before installing.
- Step 2. Mark the exhaust at the designated cut points shown on (Fig 1). Double-check measurements, then use a suitable cutting tool to make a clean, even cut. Then remove burrs and sharp edges using a file.





Step 3. Remove the stock exhaust from the exhaust insulators. See (FIG 3 & 4).

INSTALLATION:

It's recommended the PPE Exhaust System be installed in sections. Keep clamps loose to allow for adjustments.



Step 4. Install the 4" Inlet Pipe (A) onto the factory exhaust system with the 3" Exhaust Clamp (H). Secure hanger on the exhaust insulators. See (FIG 5).





Step 5. If your truck wheelbase is 147.4", proceed to Step 6.

If your truck wheelbase is 157" you will need to install the 4" Optional Straight Extension Pipe (B) with the 4" Exhaust Clamps (G).



Step 6. Install the 4" Angled Pipe (C) with the 4" Exhaust Clamps (G). Secure hanger on the exhaust insulators. See (FIG 6 & FIG 7).



Step 7. Install the 4" Over-Axle Pipe (D) with the 4" Exhaust Clamps (G). Secure hanger on the exhaust insulators. See (FIG 8 & FIG 9).





Step 8. Install the 4" 90 Deg Pipe **(E)**with the 4" Exhaust Clamps **(G)**.
See **(FIG 10)**.



Step 9. Install 4" Exhaust Clamps (G) onto the 5" Exhaust Tip (F). See (FIG 11 & FIG 12).





Step 10. Adjust fit and tighten all Exhaust Kit Clamps (G & H) starting from front to back.
